Purposes for which we process personal data

Lavide processes personal data for the following purposes:

Contact and communication

If you contact Lavide (online or offline) or subscribe to our newsletter, we process personal data such as your name and email address. The legal basis for this processing is your consent or Lavide’s legitimate interest in exchanging information with you. We may retain this data to facilitate future contact where relevant.

Investor and corporate communications

Lavide may use personal data to distribute company announcements, investor updates, and information relating to general meetings or other corporate communications.

Website usage and analytics

When you visit our website, we process technical data such as IP address, browser information, device data, and usage statistics. This processing is based on Lavide’s legitimate interest in maintaining and improving the functionality, security, and performance of its website.

Compliance with legal and regulatory obligations

Where applicable, Lavide may process personal data to comply with statutory and regulatory obligations, including obligations arising under corporate, securities, or financial market regulations.

Lavide does not use personal data for automated decision-making or profiling.

Source of processed data

Lavide primarily processes personal data that is provided directly by you.

If Lavide processes personal data that has not been obtained directly from you, such processing will only take place in connection with legitimate business activities and will

be based on publicly available sources or information obtained via regulated intermediaries.

Disclosure of your personal data

Lavide will only disclose personal data to third parties if:

- this is required by law or regulation, or
- it is necessary for the performance of services supporting Lavide's operations (such as website hosting or email distribution), and such parties act on Lavide's instructions and are subject to appropriate confidentiality and data protection obligations.

Lavide does not sell personal data.

Storage of your personal data

Lavide retains personal data only for as long as necessary for the purposes described in this Privacy Statement or as long as required under applicable laws and regulations.

Data that is no longer required will be deleted or anonymised in accordance with Lavide's internal policies.

Cookies and analytics

Lavide uses cookies and analytics tools, including Google Analytics, to obtain insight into the use of its website.

These tools may process IP addresses and usage data. Where possible, IP addresses are anonymised. Information collected via analytics is used solely for statistical and operational purposes.

You can manage or disable cookies through your browser settings.

International data transfers

Some service providers used by Lavide may process personal data outside the European Economic Area.

Where applicable, such transfers take place on the basis of appropriate safeguards, including standard contractual clauses approved by the European Commission.

Your rights in relation to the personal data we process

Under the General Data Protection Regulation, you have the right to request:

- access to your personal data
- rectification of inaccurate or incomplete data
- deletion of personal data, where legally permitted
- restriction of or objection to certain processing
- withdrawal of consent, where processing is based on consent
